# Sample tender submission form

This is a sample tender submission form to provide an overview of the information required when making a submission. All tender submissions must be lodged online via the Local Land Services website at www.lls.nsw.gov.au/tsr by 11:59pm on Friday, 9 June 2023.

# Selection of SWP

# Lease fee offer (exclusive of GST)

- be unconditional
- be a single value (not a value range)
- be exclusive of GST. (CPI increases will be applied annually to the lease fee)
- meet or exceed the minimum lease fee offer amount
- be for the whole of the SWP.

# Eligibility criteria

The details you provide here will be assessed to determine whether your Tender Submission meets the following eligibility criteria.

#### By lodging this Tender Submission form, I declare:

- 1. I am over 18 years of age (if individual)
- 2. I have read, understood, and agree to comply with the Terms of Tender (on last page)
- 3. I have or can obtain a Property Identification Code (PIC)

- 4.1 do not have any outstanding debts owing to Local Land Services
- 5.1 reside within 50km (via the most direct practical route) of the SWP Specified above
- 6. If I am granted a SWP lease, I agree to comply with the SWP lease conditions
- 7. If I am granted a SWP lease, I agree to pay the Local Land Services lease fee offered below:
  - a. before the SWP lease is granted, or
  - b. in accordance with an agreed payment schedule, as set out in the SWP lease conditions
- 8.I have submitted a Lease fee offer that meets or exceeds the advertised minimum Lease fee offer for the SWP. Note: the minimum lease fee offer for each SWP will be published on the Local Land Services website.
- 9.1 have not been subject to compliance action for one or more of the following:
  - a. unauthorised use of a SWP, or other type of TSR,
  - b. failing to comply with condition/s of a SWP lease or TSR permit.
- 10. I can obtain public liability insurance cover of at least \$20,000,000 that covers the grazing of stock on the SWP, and such insurance shall be valid for the duration of the permit.

### **Evaluation Criteria**

The details you provide here will used to assess:

- the likely environmental impacts arising out of the proposed grazing, and
- the Tenderer's capability to comply with SWP lease conditions, and
- the Tenderer's capability to appropriately manage the SWP for the duration of the lease

To ensure the appropriate ongoing land management and maintenance of the SWP.

The assessment is based on the following Evaluation Criteria:

# 1. What type of stock will be grazed on the SWP?

- Beef Cattle
- Sheep
- Goats
- Horses
- Other

Note: Your answer to this question helps us to understand the likely environmental impacts arising out of the proposed grazing. Different types of stock have different impacts on the environment.

## 2. Which option below best describes your grazing practices?

- a. I am specifically authorised in writing by Local Land Services, or
- b. The information is necessarily disclosed to others (who are also bound to keep the information confidential) for the purposes of enabling me to prepare a tender submission.

I agree that I am liable for all expenses or costs incurred by me because of my participation in the Tender Process, including if the Tender Process is terminated.
