TIPS AND SUGGESTIONS

- The Northern Tablelands Local Land Services (LLS) is committed to working with land managers to invest in the long term sustainability of agricultural businesses. We encourage and invite innovative land managers to apply for funding that supports improved management of natural resources across the region. Funding is available for on-ground projects that achieve improved natural resource management and farm production.
- Talk to your neighbours! Projects that extend across more than one property are encouraged and receive a higher weighting in the assessment compared to standalone projects. The more landholders either neighbouring or sharing a common geographic area the greater the weighting in the assessment.
- If there are three or more landholders either as neighbours or common geographic area please indicate in your EOI that you are part of a group.
- Applicants must make an equal or greater contribution for every \$ (in-kind or financial contribution) to the project.
- Typically project works are to be completed within a 12 to 18 month time frame. The Northern Tablelands LLS will work with you throughout implementation and offer additional support
- Successful applicants will be required to enter into a Management Agreement with the Northern Tablelands LLS.
- Individual applications of up to \$30,000

Please note that work you undertake before or after the timeframe for the project, or work that has already been completed at the time of application is not eligible for funding.

WHO IS ELIGIBLE FOR FUNDING?

- Individual landholders in the Northern Tablelands LLS region*
- Groups of landholders (this may include Landcare groups, producer groups, neighbouring landholders working together etc.)
- Local Government (however the available funding for Local Government is limited)
- Community groups wishing to improve natural resource management

* The Northern Tablelands LLS region is defined as within the Tenterfield, Glen Innes Severn, Guyra, Inverell, Armidale, Uralla and Walcha Shires.
